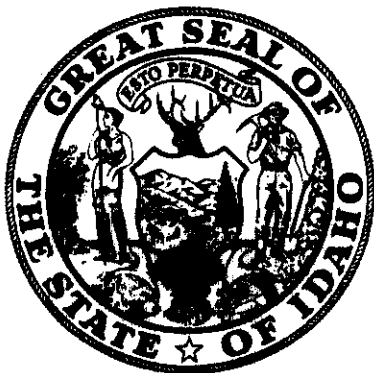

ARTICLES OF INCORPORATION OF  
LANCE LINCOLN DDS, P.A.

The undersigned, being a person legally competent to enter into contracts, and being a dentist qualified to practice dentistry pursuant to the laws of the State of Idaho, for the purpose of forming a professional corporation under the "Professional Corporation Act" of the State of Idaho, does hereby adopt the following Articles of Incorporation.

FIRST: The name of the corporation is Lance Lincoln DDS, P.A.

SECOND: The period of its duration is perpetual.

THIRD: PURPOSES: The purposes for which the corporation is formed are:

To practice dentistry and to carry out such purposes by means of employing duly licensed dentists, and such nurses, technicians, and other personnel as are necessary; and be authorized to receive and collect fees or compensation for the services rendered by such licensed dentists.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 500 shares at no par value.

FIFTH: Provisions denying preemptive rights are none.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are none.

SEVENTH: The address of the initial registered office of the corporation is 102 South Washington, Moscow, Idaho 83843, and the name of its initial registered agent at such address is Lance Lincoln.

EIGHTH: The number of directors constituting the initial board of directors of the corporation is one, and the name and address of the person who is to serve as director until the first annual meeting of shareholders or until his successor is elected and shall qualify is: Lance Lincoln, 102 South Washington, Moscow, Idaho 83843.

NINTH: The name and address of the incorporator is: Lance Lincoln, 102 South Washington, Moscow, Idaho 83843.
