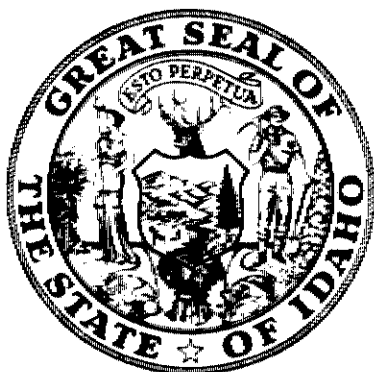

**AMENDED ARTICLES OF INCORPORATION
FUTURE TECHNOLOGY, INC.**

PURSUANT TO Sections 30-1-59 through 30-1-62 of the Business Corporation Act of the State of Idaho, the above named Corporation adopts the following Amended Articles of Incorporation to its original Articles of Incorporation.

I.

The Board of Directors of the aforementioned Corporation have adopted a resolution dated August 15, 1991, setting forth this proposed amendment to the original Articles of Incorporation.

II.

The Board of Directors submitted the proposed amendment at a special meeting of the Shareholders which was held on August 15, 1991. That special notice was sent out to all Shareholders setting forth the proposed amendment prior to the special meeting of the Shareholders.

After a motion duly made and seconded, it was unanimously approved by the Directors and Shareholders that the name of the corporation shall be changed from FUTURE TECHNOLOGY, INC. to SURETRAK, INC.

III.

That the designated Amendment to the Articles of Incorporation does hereby supersede the original Articles of Incorporation as set forth herein.

IV.

On the date of adoption of such amendments, the number of shares outstanding was Fifteen Thousand Six Hundred Twelve (15,612), being all of one class. All Fifteen Thousand Six Hundred Twelve (15,612) of the issued shares of the Corporation voted for the amendment.

V.

Except for the above designated amendment, these Amended Articles of Incorporation adopt the corresponding provisions of the original Articles of Incorporation without change.
