The incorporators and initial directors of Kneeland, Korb, Collier, Legg, & Haukaas, P.A. voluntarily dissolve such corporation by adopting the following Articles of Dissolution pursuant to I.C. section 30-1-82:

1. The name of the corporation and post office address is Kneeland, Korb, Collier, Legg & Haukaas, P.A., Post Office Box 249, Ketchum, Idaho 83340.
 2. The date of the issuance of its articles of incorporation was January 9, 1992.
 3. None of its shares have been issued.
