12 of the directors of said corporation.

13 2. That Ketchum Livestock Association has 4,090 shares of outstanding
14 capital stock and that the holders of more than two-thirds of said outstanding
15 capital stock of said Ketchum Livestock Association have, within the past thirty
16 days, given their written assent to amend the Articles of Incorporation of the
17 corporation to provide for the perpetual existence of the corporation by amending
18 Article No. 4 of said Articles of Incorporation, which presently reads as follows:

19 "4 The term for which this corporation is to
20 exist, shall be fifty (50) years."

21 so that the Article No. 4, as amended, shall read as follows:

22 "4 That the term for which said corporation
23 shall exist is perpetual."

24 That none of such written consents have been revoked but are all in full force
25 and effect.

26 WHEREFORE, said Articles of Incorporation have been amended to give
27 such corporation perpetual existence.

28 IN WITNESS WHEREOF, the said W. S. Brailsford and Clyde R. Bacon,
29 being a majority of the board of directors of Ketchum Livestock Association,
30 have hereunto set their hands and affixed the seal of said corporation this 5th
