ARTICLES OF AMENDMENT

to the

ARTICLES OF INCORPORATION

of

FIRST CHURCH OF GOD OF JEROME, IDAHO, INC.

Pursuant to the provisions of Section 30-326 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is: First Church of God of Jerome, Idaho, Inc.

SECOND: The following amendments of the Articles of Incorporation were adopted as proposed by the board of directors on February 16, 1980, and such amendments were approved by the membership at a special meeting held on February 24, 1980, after proper notice having been given to all persons entitled to such notice. Said amendments were adopted in the manner prescribed by the Idaho Business Corporation Act and are as follows:

Section 3 of said Articles of Incorporation are amended as follows:

- 1. The corporation is organized exclusively for religious, charitable, scientific, literary, or education purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code.
- 2. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code.
- 3. Upon the winding up and dissolution of the corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a non-profit fund, foundation or corporation which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.

All other provisions of said Articles of Incorporation

shall remain in full force and effect and unchanged by this amendment.

THIRD: At the time this amendment was approved by the membership of the corporation there were 60 members of said corporation entitled then to vote on such amendment. At the special meeting held on February 24, 1980, as above-mentioned, 60 persons voted in the affirmative for said amendment and no persons voted against said amendment.
