ARTICLE I.

The name of the Corporation is SLIPSTREAM, INC.

ARTICLE II.

This corporation is a nonprofit corporation within the meaning of the Idaho Nonprofit Corporation Act, and its existence shall be perpetual.

ARTICLE III.

The purpose of this corporation is to engage in the community service, primarily both land and air search and rescue through the auspices of the Civil Air Patrol, an auxiliary of the United States Air Force, and to train its members in those proficiencies.

ARTICLE IV.

The principal office for the transaction of business of the Corporation and its registered office is Route 2, Box 37, Grangeville, Idaho County, Idaho 83530, and its mailing address is P. O. Box 69, Grangeville, ID 83530-0069.

ARTICLE V.

There shall be at least three, but not more than nine directors of the Corporation.

ARTICLE VI.

This corporation shall consist of its members who, to be members must have a current membership card in the Civil Air Patrol. Members shall meet from time to time at the call of its commanding officer, or in his absence, its deputy commander.

The annual meeting shall be the first monday in December, and notice thereof shall be given in the manner provided by law and the corporate by-laws.

ARTICLE VIII.

The management of this corporation shall be by its board of directors.
