KNOW ALL MEN BY THESE PRESENTS, that we the undersigned, hereby execute this CERTIFICATE of Limited Partnership of Idaho Aquatic Farms Limited Partnership pursuant to the provisions of the Limited partnership laws of the State of Idaho and hereby certify as follows:

I

The name of the limited partnership is Idaho Aquatic Farms Limited Partnership.

II

The general character of the business is to engage in the business of growing, processing and selling crustaceans, fish and related products for commercial purposes, and in connection therewith to lease and / or purchase real property and construct improvements thereon to be used to conduct said business.

III

The registered agent for service of process is Geo-Tech Systems Inc., c/o Phillip J. Hanson located at 91 Springhill Drive, Eagle, Idaho 83616.

IV

The name and business address of each partner, listed separately for general partners and limited partners is as set forth on the Exhibit A attached hereto and incorporated herein.

V

The amount of cash and the agreed to value of other property, including labor and services, contributed by each partner is as shown on Exhibit A.

VI

There are no times on events on the happening of which additional contributions are to be made by any partner and no general or limited partner shall be required to make additional contributions in excess of that shown on Exhibit A.

VII

The power of a limited partner to transfer his interest is restricted and such restrictions, and terms and conditions thereto are set out in Article XVI of the Articles of Limited

Partnership of Idaho Aquatic Farms Limited Partnership
(Articles").

VIII

A partner may not terminate his membership in the Limited Partnership.

IX

No partner has a right to receive distributions of property, other than cash.

X

No partner has a right to receive, nor a general partner to make, distributions to a partner which include a return of all or any part of the partner's contribution.

XI

The partnership may be dissolved upon the happening of any of the events set out in Section 17.1 of the Articles.

XII

There is only one general partner and upon its withdrawal the Limited Partners may designate a substitute general partner to continue the Partnership, but only under the terms and conditions of Sub-Section 17.1 (b) of the Articles.

XIII

Article XVIII of the Articles provides, in part, that the limited partners, irrevocably constitute and appoint the general partner their attorney in fact to execute certain documents including this certificate and all subsequent amendments hereto. Said power of attorney is a special power of attorney as more fully set out in said Article.
