Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Applied Engineering Services, Inc.

SECOND: The following amendments to the Articles of Incorporation were adopted by the shareholders of the corporation on April 25, 1997, in the manner prescribed by the Idaho Business Corporation Act:

1. The following new ARTICLE SIX is adopted in place of ARTICLE SIX of the current Articles of Incorporation of the corporation, adopted March 5, 1992:

BOARD OF DIRECTORS The number of directors constituting the board of directors of the corporation shall be one.

THIRD: The date of the adoption of the foregoing amendment by the shareholders was April 25, 1997.

SIXTH: The foregoing Amendment to the Articles of Incorporation do not provide for an exchange, reclassification or cancellation of the existing shares of common stock of the corporation.

SEVENTH: Such amendments do not effect any change in the amount of stated capital of the corporation.
