ARTICLES OF INCORPORATECHETARY OF STATE

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following articles of Incorporation for such corporation.

FIRST: The name of the corporation is Shield Construction, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

- (a) To engage in the business of construction, repairing and remodeling of buildings and public works of all kinds and the doing of any other business and contracting incidental thereto.
- (b) To engage in the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 25,000 shares at a par value of \$1.00 per share.

FIFTH: The address of the initial registered office of the corporation is 3505 Hawthorne Street, Boise, Idaho 83704, and the name of its initial registered agent at this address is Alvin G. Stoeger.
