ARTICLES OF INCORPORATION - 1

ARTICLE VI.

Directors.

The number of directors shall be as specified in the Bylaws of this corporation and such number may from time to time be increased or decreased in such manner as described in the Bylaws and may be fewer than three in the event that the corporation has less than three shareholders, in accordance with the laws of the State of Idaho. ARTICLE VIII.

Provisions for Regulation of Corporation's Internal Affairs.

Section 5. <u>Indemnification of Directors and Officers</u>. The Bylaws of the corporation shall provide for the circumstances in which Directors and Officers of the corporation may be entitled to indemnification.

Amendment of Articles of Incorporation.
