Pursuant to the provisions of the Idaho Code, Section 30-1-61, the undersigned incorporators hereby adopt the following Articles of Amendment to the Articles of Incorporation of Ag Decisions, Inc.:

Article I

The name of this corporation is Ag Decisions, Inc.

Article II

The following amendment is made to the Articles of Incorporation:

1. Article IV, first sentence revised to read: "The amount of the total authorized capital stock of this corporation is 10,000,000 shares of no par value."

2. Article IV, delete: "Each stockholder shall offer to the Corporation or to other stockholders of the corporation a thirty (30) day "first refusal" option to purchase his stock should he elect to sell his stock."

3. Article VII, delete: "The Bylaws shall determine whether and to what extent the accounts and books of this corporation, or any of them shall be open to the inspection of the stockholders; and no stockholder shall have any right of inspecting any account or book or document of this Corporation, except as conferred by the law of the Bylaws, or by resolution of the stockholders."

4. Article VII, add: "No stockholder shall have preemptive rights under Section 30-1-26 of the Idaho Code."
