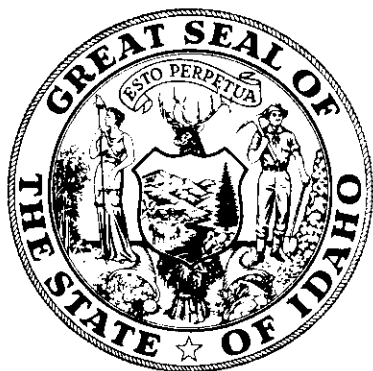

ARTICLES OF AMENDMENT TO  
THE ARTICLES OF INCORPORATION OF  
REMER & TROY INSURANCE AGENCY, INC.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST:           The name of the corporation is Remer & Troy Insurance Agency, Inc..

SECOND:           The following amendment to the Articles of Incorporation was adopted by the shareholders of the corporation on December 2, 1985, in the manner prescribed by the Idaho Business Corporation Act:

Article First of the corporation's Articles of Incorporation be, and the same hereby is, amended by changing the name of the corporation from Remer & Troy Insurance Agency, Inc., to Troy Insurance Agency, Inc.

THIRD:           The amendment to the Articles of Incorporation was adopted by the shareholders of the corporation at a special meeting of the shareholders of the corporation duly and regularly called for the purpose of amending the Articles of Incorporation on December 2, 1985.

FOURTH:           The number of shares of issued and outstanding capital stock of the corporation is 34,091, and the number of shares entitled to vote upon this amendment is 34,091.

FIFTH:           The number of shares voting for the amendment was 34,091 shares, and no shares voted against the amendment.
