


**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION 35 APR 26 AM 10 56

The undersigned, acting as the incorporators of a corporation (hereinafter referred to as the "Corporation") organized pursuant to and subject to the Idaho Business Corporation Act, Chapter 1, Title 30, Idaho Code, as now existing or hereafter amended and supplemented (the "Act"), adopt the following Articles of Incorporation for the Corporation.

ARTICLE I. NAME

The name of the Corporation is Doctors Magnetic Resonance, Inc.

ARTICLE II. PERIOD OF DURATION

The period of duration of the Corporation is perpetual.

ARTICLE III. PURPOSES

The purposes for which the Corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Act; to do everything necessary, proper, advisable or convenient for the conduct of said business; and to do all other things incident thereto or connected therewith which are not forbidden by the Act, by other law or by these Articles of Incorporation.

ARTICLE IV. AUTHORIZED SHARES

The aggregate number of shares of capital stock which the Corporation shall have authority to issue is 10,000 shares, of one class only. The par value of each share is \$1.00.

ARTICLE V. CAPITAL SURPLUS

When and as determined by the Board of Directors, the Corporation shall have the right to purchase and redeem its own shares to the extent of unreserved and unrestricted capital surplus available therefor.

To the extent authorized by the Act, when and as determined by the Board of Directors, the Corporation may, from time to time, distribute to its shareholders out of capital surplus of the Corporation a portion of its assets in cash or property.

#### ARTICLE VI. REGISTERED OFFICE AND AGENT

The address of the initial registered office of the Corporation is 999 North Curtis Road, Boise, Idaho 83706, and the name of its initial registered agent at that office is Thomas E. Henson, M.D.

#### ARTICLE VII. BOARD OF DIRECTORS

The number of Directors of the Corporation shall be five (5). Directors must be shareholders of the Corporation. The number of directors constituting the initial Board of Directors is five (5), and the name and address of the persons who are to serve as Directors until the first annual meeting of the shareholders and until their successors shall have been elected and qualified are:
