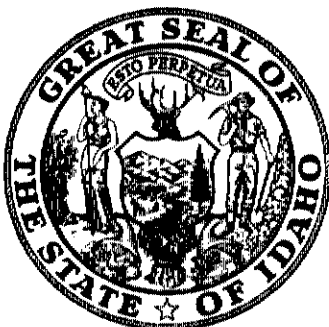


KNOW ALL MEN BY THESE PRESENTS:

- b. G. Richard Bevan having withdrawn as a director, employee, and shareholder from the corporation, the following amendment is adopted:


THE NAME OF THE CORPORATION SHALL BE HOLLIFIELD
