ARTICLES OF INCORPORATION

OF

VAQUERO RIDGE OWNERS' ASSOCIATION, SINC.

(A NONPROFIT CORPORATION)

The undersigned, acting as incorporator of a monprofit corporation under the Idaho Nonprofit Corporation Act, adopts the following Articles of Incorporation for such nonprofit corporation:

ARTICLE I

The name of the corporation is VAQUERO RIDGE OWNERS' ASSOCIATION, INC.

ARTICLE II

The duration of the corporation is perpetual.

ARTICLE III

The purpose or purposes for which the corporation is organized are: to perform any and all acts which may be necessary or proper for, or incidental to proper management and operation of the common areas of the Vaquero Ridge Subdivision and performance of the other responsibilities of the corporation as granted and assigned by the Declaration of Protective Covenants, Conditions and Restrictions of said subdivision as recorded in Ada County, Idaho; and, the transaction of any or all lawful business for which nonprofit corporations may be incorporated under the Idaho Nonprofit Corporation Act.

ARTICLE IV

The corporation shall have members, who shall qualify as for membership by an ownership interest in any lot in the Vaquero Ridge Subdivision. Upon dissolution the corporation shall transfer its remaining assets to its members in equal shares as it winds up and liquidates its affairs.

ARTICLE V

Provisions for the regulation of the internal affairs of the corporation are the By-Laws of the corporation, consistent with the Declaration of Protective Covenants, Conditions and Restrictions of the Vaquero Ridge Subdivision, as they may be amended.

ARTICLE VI

Pursuant to Idaho Code Section 30-3-49, any action required by the Idaho Nonprofit Corporation Act to be taken at a meeting of the members may be taken without a meeting if a consent in writing,

setting forth the action so taken, is signed by all of the members entitled to vote with respect to the subject matter thereof; such consent shall have the same effect as a unanimous vote of members.

ARTICLE VII
