**THE UNDERSIGNED**, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

**FIRST**

The name of the corporation is Larson Architects, P.A.

**SECOND**

The period of its duration is perpetual.

**THIRD**

The purposes for which the Corporation is organized are: to render architectural professional services and any and all service ancillary thereto, provided that such professional services shall be rendered only through its officers, employees and agents who are duly licensed or otherwise legally authorized to render such professional services within the State of Idaho; to do everything necessary, proper, advisable or convenient, for the conduct of such professional services; and to do all other things related thereto or connected therewith, which are not forbidden by the laws of the State of Idaho or by these Articles of Incorporation.

The Corporation shall not engage in any business other than rendering the aforementioned services; provided, however, that the Corporation may own real and personal property necessary or appropriate for rendering the type of professional services for which it is organized, may invest its funds in real estate, mortgages, stock, bonds and any other type of investment, and may enter into contracts, appoint agents, borrow money, incur indebtedness, and do any and all other lawful things necessary or proper to the transaction of the affairs and purposes of the Corporation.

The Corporation shall have and may exercise all powers now or hereafter granted to professional corporations organized under the laws of the State of Idaho, and all such powers necessary or convenient to effect its purposes.

**FOURTH**

The corporation is authorized to issue 100,000 shares of no par value common voting stock.


