ARTICLES ON THICORPORATION

We, the undersigned, being three or more natural persons of full age, at least two-thirds of whom are citizens of the United States or of its territories or possessions, have this day voluntarily associated ourselves for the purpose of forming a private corporation under the laws of the State of Idaho, and to that end hereby adopt articles of incorporation as follows:

ARTICLES ONE. The name of the corporation is Starbridge Entertainment, Incorporated.

ARTICLE TWO. The purposes of the corporation are to engage in the financing, production, and selling of television programs and motion pictures; and to broadcast, disseminate, distribute, transmit, retransmit, receive, or collect by electrical, electronic, or any other means, music, entertainment, news, speeches, sermons, advertising, educational and informative matter, photographs, pictures, scenes, or plays, and to provide for the use of other facilities for such purposes.

ARTICLE THREE. The duration of the corporation is perpetual.

ARTICLE FOUR. The location and post office address of the registered office of the corporation in the State of Idaho is 2805 Starlington Drive, City of Boise, County of Ada, 83712, and the name of its registered agent at such address is W.B. Fawcett.

ARTICLE FIVE. The total authorized number of shares of stock is 100. All of such shares of stock are without par value.
