ROYATE CROWN COEA BOTTLING COMPANY AN Idaho corporation, has merged with ROYAL CROWN BOTTLING COMPANY OF SOUTHEASTERN IDAHO, INC., with ROYAL CROWN BOTTLING COMPANY OF SOUTHEASTERN IDAHO, INC., being the surviving corporation.

- 1. Plan of Merger: All of the stock of Royal Crown
 Cola Bottling Company is owned by Royal Crown Bottling Company of
 Southeastern Idaho, Inc. The plan of merger adopted by these
 corporations in their Merger Agreement provided for the merger of
 Royal Crown Cola Bottling Company into Royal Crown Bottling
 Company of Southeastern Idaho, Inc., with Royal Crown Bottling
 Company of Southeastern Idaho, Inc., being the surviving corporation.
- 2. <u>Number of Shares Outstanding</u>: The number of shares outstanding of the subsidiary corporation, Royal Crown Cola Bottling Company, is five hundred (500). There is just one class of stock of Royal Crown Cola Bottling Company, and all of that stock is owned by Royal Crown Bottling Company of Southeastern Idaho, Inc.
- 3. It was not necessary to mail a copy of the plan of merger to the shareholders of the subsidiary corporation, because the only shareholder of the subsidiary corporation was Royal Crown Bottling Company of Southeastern Idaho, Inc., and that corporation approved the Merger Agreement through its Board of Directors and executed the Merger Agreement by its proper officers.
