Articles of Incorporation Amendments

ARTICLE ONE. Name. The name of the corporation is **SILVER VALLEY HABITAT, INC.**; and said Corporation is organized pursuant to the Idaho Nonprofit corporation Code and is a nonprofit corporation as described in Section 501(c)(3) of the Internal Revenue Code, as amended.

ARTICLE THREE. Powers. The powers of the Corporation shall include the following:

(c) In the event of the dissolution and liquidation of this Corporation, to the extent allowed or permitted under applicable laws, the property and assets of the Corporation shall be, as determined by the Board of Directors, distributed to or sold and the proceeds of such sales distributed to any other organization(s) organized and operating for the same purposes for which the Corporation is organized and operating or any organization(s), foundation(s), fund(s), or corporation(s) organized and operating exclusively for religious, charitable, scientific, or educational, or other purposes permitted by Section 501(c)(3) of the Internal Revenue Code, as amended, all of which such organizations, foundations, funds, or corporations shall be exempt under Section 501(c)(3) of the Internal Revenue Code, as amended. In the event that any assets are not disposed of in accordance with the provisions of these Articles of Incorporation or that the Corporation shall fail to act within a reasonable time in the manner provided in these Articles of Incorporation, the District Court of Shoshone County shall, upon application of one or more persons having a real interest in the Corporation or its assets, make such distribution(s) as provided in these Articles of Incorporation.

ARTICLE FIVE. Registered Office and Registered Agent. The address of the Corporation's initial registered office in the State of Idaho is 301 S. Division, City of Kellogg, County of Shoshone, Idaho 83837. The name of the Corporation's registered agent is Judith L. Blalack.
