We hereby certify that a special meeting of the stockholders of Modern Prospectors, Inc., a corporation organized and existing under and by virtue of the laws of the State of Idaho and qualified to do business in said State and maintaining its principal office at Kellogg, Shoshone County, State of Idaho, was held on the 4th day of September, 1952, at the hour of 10:00 o'clock A.M. (Mountain Standard Time) of said day, at 412 Main Street, Kellogg, Shoshone County, Idaho, pursuant to thirty days' notice to all stockholders of record, notifying said stockholders of said special meeting and the purposes thereof, to be held on the 4th day of September, 1952, at said hour and place, and thereafter said meeting was continued to the 25th day of September, 1952, at the same time and place.

At said adjourned meeting more than two-thirds of the issued and outstanding stock entitled to vote at said meeting was present and voting. A copy of said notice of meeting, together with Affidavit of mailing of said notices, is filed in the record books of said corporation.

be amended to read:

"The name of this corporation shall be Pacific Minerals, Inc."
