# ARTICLES OF INCORPORATION OF CAPITAL CITY YOUTH BALLET, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Nonprofit Corporation Act, adopts the following Articles of Incorporation for such corporation:

## FIRST:

The name of the corporation is Capital City Youth Ballet, Inc.

### SECOND

The corporation is a nonprofit corporation.

# **THIRD**

The period of its duration is perpetual.

### **FOURTH**

This corporation is organized for the following purposes:

- A. To cultivate, promote, foster, sponsor, and develop among its members and the public the appreciation, understanding, taste, study and love of ballet; to create a center for the advancement of such purposes; to secure the interest of patrons of this art; to encourage the composition of ballets for youth, choreography, books and music for junior ballets for production by the company so as to provide social activities, entertainment and education and the voluntary development of the talents for ballet among youth, and to enhance the status of junior performers. To function as a training ground for dancers who wish to pursue careers as professional performers, furthering their training and developing their abilities as performers, all for no pecuniary gain; and lawfully do all things necessary, suitable and proper for the accomplishment for these purposes.
- B. To engage in the activity incidental or conducive to the attainment of the purpose of this corporation.
- C. To engage in any or all-lawful purposes for which the corporation may be incorporated under the Idaho Nonprofit Corporation Act.

This corporation is organized exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of Section 501(c)(3) of the internal Revenue Code. Notwithstanding any other provision of theses articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501©(3) of the Internal Revenue Code.
