# ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, That Charles C. Jones hereby incorporates a corporation under and pursuant to the laws of the State of Idaho relative to private corporations, and hereby adopts and executes the following ARTICLES OF INCORPORATION thereof:

## Article 1.

The name of this corporation is Contential Pay Telephones, Inc. - a perpetual corporation

## Article 2.

The aggregate number of shares which the corporation shall have authority to issue is 1,000 shares - no par value.

## Article 3.

The address of said corporation's initial registered office 1310 Vista Avenue, Suite 25, Boise, Idaho 83705 and the name of its initial registered agent at said address is:

## Article 4.

## Article 5.

Article 6.

No director of the corporation shall be personally liable to the corporation or its shareholders for monetary damages for conduct as a director, except that this provision shall not apply to:

1. Any breach of the director's duty of loyalty to the corporation or its shareholders;
2. Any acts or omissions not in good faith or which involves intentional misconduct or a knowing violation of law;
3. Any distribution which is unlawful under Idaho law;
4. Any transaction from which the director derived an improper personal benefit;
5. Any act or omission occurring prior to the date on which these Articles of Incorporation are filed with the Secretary of State.

Article 7.

The purpose of the corporation shall be any lawful business including the sales of "Video game equipment, all coin operated vending machines, including obtaining locations for coin operated vending machines.
