

ARTICLES OF INCORPORATION
OF
THE IDAHO FALLS INVESTMENT COMPANY.

We, the undersigned, bona fide residents of the State of Idaho hereby and by these Articles of Incorporation associate ourselves together for the purpose of forming a corporation under the laws of the State of Idaho.

I

The name of the corporation shall be THE IDAHO FALLS INVESTMENT COMPANY.

II

The purposes for which the corporation is formed are the following:

To engage in business of every kind and character within or without the State of Idaho, including the business of owning, selling and hypothecating real and personal property; acting as agent for others in the sale and hypothecation and other dealing in real and personal property; acting as agent for parties in any line of business in the State of Idaho in which an individual could act as agent; purchasing, leasing, constructing and dealing in buildings of all kinds and characters, and doing all things necessary to further the interest of the company in any of said lines; purchasing, selling, and in all other manners dealing in mercantile and business establishments and acting as agent for others in said lines; acting as trustee in all matters in which an individual could act as trustee; to do all things necessary or convenient

in the opinion of the board of directors for the carrying on of any business upon which the company may embark consistent with the purposes aforesaid.

III

The principal place of business of the company shall be Pocatello, Bannock County, Idaho.

IV

The term for which the corporation is to exist shall be fifty (50) years.

V

The business and prudential affairs of the company shall be managed by a board of three directors.

VI

The amount of the capital stock of the company is Twenty-five Thousand (\$25,000.00) Dollars, divided into two hundred fifty (250) shares of the par value of One Hundred (\$100.00) Dollars each.
