AMENDMENT TO ARTICLES OF INCORPORATION

COMES NOW THE DIRECTORS OF THE DEPOT INSTITUTE, LIMITED
AND AMEND THE ARTICLES OF INCORPORATION IN THE FOLLOWING
PARTICULARS:

A new Article, Article XI. is hereby adopted:

ARTICLE XI.

This organization is organized exclusively for
charitable purposes within the meaning of section
501(c)(3) of the Internal Revenue Code.

"Notwithstanding any other provision of these
articles, the corporation shall not carry on any
other activities not permitted to be carried on (a)
by a corporation exempt from Federal income tax under
section 501(c)(3) of the Internal Revenue Code of 1954
(or the corresponding provision of any future United
States Internal Revenue Law) or (b) by a corporation
contributions to which are deductible under section
170(c)(2) of the Internal Revenue Code of 1954 (or
corresponding provision of any future United States
Internal Revenue Law).

The Board of Directors, who comprise the entire
membership, voted unanimously to adopt this Amendment
to the Articles of Incorporation at a meeting on
22 day of September 1988.
