

ARTICLES OF INCORPORATION

OF

JEROME COUNTY CONCERNED CITIZENS, INC.

The undersigned, acting as incorporators of a non-profit corporation under the Idaho Nonprofit Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is JEROME COUNTY CONCERNED CITIZENS, INC.

SECOND: Said corporation is a non-profit corporation. The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized is to promote a wholesome environment in the County of Jerome, State of Idaho.

FOURTH: The corporation has and will have additional members, and the management of the affairs of the corporation are to be vested in its Board of Directors pursuant to Idaho Code, 30-314(c).

FIFTH: The address of the initial registered office of the corporation is 819 East Avenue C, Jerome, ID. 83338, and the name of its initial registered agent at such address is Janet D. Babcock.

SIXTH: The number of directors constituting the initial board of directors of the corporation is three (3) and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:
