## GEM STATE INDUSTRIAL PARK CORPORATION

KNOW ALL MEN BY THESE PRESENTS, that we, ROBERT H. BOGNER, CHRISTINE M. BOGNER and WILLIAM T. MARKS, all being over the age of twenty-one years and citizens of the United States of America, do hereby associate ourselves for the purpose of forming a corporation under the laws of the State of Idaho, and do hereby certify and adopt the following Articles of Incorporation.

#### ARTICLE I.

The name of this corporation shall be Gem State Industrial Park Corporation.

## ARTICLE II.

The time of the existence of this corporation shall be perpetual.

#### ARTICLE III.

The amount of capital stock of this corporation shall be \$100,000.00 divided into 1,000 shares of the par value of \$100.00 per share.

# ARTICLE IV.

The purposes and objects for which this corporation is formed is to own, manage and operate an industrial park, to engage in any commercial, industrial, agricultural enterprise calculated to be profitable to the corporation and permitted by the laws of the State of Idaho; to generally engage in, do and perform any enterprise, act or vocation that a natural person might or could do or perform. To

engage in the manufacture, sale, purchase of merchandise and personal property of all manner and descriptions. To buy, sell, deal in, lease, hold or improve real estate or any interest therein. To act as agent, broker or attorney in fact for any person, persons or corporations.

To loan money, to borrow money, to execute and deliver notes, certificates of indebtedness, debentures, bonds and other evidence of indebtedness and as security therefor, to mortgage, pledge or hypothecate real or personal property, and to do all other things necessary and proper to be done in engaging in any lawful business purpose as permitted by the laws of the State of Idaho.
