# ARTICLES OF INCORPORATION OF DOUBLE L MANUFACTURING, INCORPORATED

I, the undersigned being a United States citizens of legal age and a resident of the state of Idaho, adopt the following Articles of Incorporation under the provisions of the Idaho Business Corporation Act (Title 30, Idaho Code):

## FIRST

the Corporation is DOUBLE L MANUFACTURING, The name of INCORPORATED.

# SECOND

The Corporation is to be perpetual.

THIRD

The purpose of this Corporation is to transact any and all legal business.

#### FOURTH

The Corporation shall have authority to issue 50,000 shares of one class of non-assessable common stock. The shares of stock shall have a par value of \$10.00. The shares of stock shall not be issued until they are fully paid for.

# FIETH

No shareholder of the corporation shall have any pre-emptive or preferential right of subscription to any shares of any class of stock, or to any obligations convertible into shares, issued or sold, other than such rights as determined by the Board of Directors.

#### SIXIH

All of the shares of common stock issued shall have equal value, without any pre-emptive or preferential rights.

# SEVENTH

#### EIGHTH

The initial Board of Directors shall consist of one Director.
