ARTICLES OF INCORPORATION

OF

NORTHWESTERN SALES PROMOTIONAL FUND, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

 $\overline{\text{FIRST}}$: The name of the corporation is NORTHWESTERN SALES PROMOTIONAL FUND, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purposes for which the corporation is organized are to encourage and promote efficiency in the conduct of dealers engaged in the sale of Kirby vacuum cleaners and related items in the Pacific-Canadian Division and to eliminate unwise and unfair business practices and to advise, assist, and provide incentives and educational opportunities for the dealers, and to act as trustee for funds provided to carry out the above purposes and for the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

<u>FOURTH</u>: The aggregate number of shares which the corporation shall have authority to issue is 5,000 shares; and the aggregate par value of the total authorized number of par value shares is \$5,000.00.
