# ARTICLES OF INCORPORATION OF C AND B AERIAL SERVICES, INC.

THE UNDERSIGNED, CARMA BAUER, BRUCE BAUER and LLOYD J.

WEBB, residents of Cassia and Twin Falls Counties, State of Idaho,
each and all citizens of the United States, of the age of majority,
do hereby associate themselves together for the purpose of forming
a corporation under the laws of the State of Idaho, and to that
end do hereby adopt and execute the following Articles of Incorporation, and do hereby certify and declare:

Τ.

The name of the corporation is C AND B AERIAL SERVICES, INC.

II.

The corporation is formed for the following purposes:

- A. To engage in activities associated with commercial aviation, including aerial application of chemicals in agricultural and grazing areas and aerial spraying and seeding of a general nature and all activities incidental to the commercial application and seeding purposes described.
- B. To engage in aerial photography, mapping, surveying and other like activities.
- C. To engage in air transportation to the extent permitted by law and instruction of students leading to their certification as operators of aircraft.
- D. To engage in dusting, spraying, defoliation, fertilizing and seeding through ground operations and the use of vehicular spraying and seeding mechanisms.
- E. To receive, acquire, hold, purchase, dispose of, convey, mortgage and/or lease, real and personal property, to dispose of, sell, lease, assign, transfer, mortgage and/or convey any rights, privileges, franchises, real or personal property of the corporation, other than its franchise as a corporation; to acquire, purchase, guarantee, hold, mortgage, own, vote, sell,

pledge and/or otherwise dispose of or deal in shares, bonds, securities and debentures and other evidence of indebtedness of its own and other corporations, domestic or foreign; to pledge, mortgage and otherwise encumber the assets of the corporation.

- F. To conduct business in this State, other States, the District of Columbia, Territories, and other possessions of the United States of America, and in foreign countries, and to have one or more offices or places of business out of this State.
- G. To enter into, make, perform and carry out contracts of every kind and for every lawful purpose, without limit as to amount, with any person, firm, association, corporation, municipality, state or government, or any subdivision, district or department of any state, municipality or government, and to engage in association with other corporations, partnerships, associations and individuals in the joint operation of legitimate business endeavor, and to acquire, hold, purchase, the assets, franchises, permits, good will of other operational organizations of whatever legal capacity engaged in business pursuits similar to those of this corporation.
- H. To do any and all such other acts, things, business in any manner connected with or necessary, incidental, convenient or auxiliary to any of the objects hereinbefore enumerated, or calculated, directly or indirectly, to promote the interest of the corporation, including research, study, development, extension of credit, loans, or any other legitimate action directed to promote the interests of the corporation; and in carrying on its purposes, or for the purpose of attaining or furthering any of its purposes or allied objectives.
- I. The several clauses contained in this statement of purposes shall be construed as both purposes and powers, and the

statements contained in each clause shall be in nowise limited or restricted, by reference to, or inference from, the terms of any other clause, but shall be regarded as independent purposes and powers; and no recitation, expression, or declaration of specific or special powers or purposes herein enumerated shall be deemed to be exclusive; it is hereby expressly declared that any other lawful purposes not inconsistent with these Articles are intended to, and hereby are, included as purposes and powers of this corporation.

III.

The registered office of the corporation shall be Burley, Cassia County, State of Idaho.

IV.

Subject to dissolution in the manner provided by law, the duration of this corporation shall be perpetual.

V.

The corporation shall be governed by a Board of Directors. The number of members of the Board shall be provided by the By-Laws of the corporation, but shall not be less than three nor more than five. The qualifications, duties, powers, limitations, and other facts relevant to the functions of the Board of Directors shall be set out in the By-Laws of this corporation, subject to the laws of the State of Idaho.

VI.

The Board of Directors of this corporation shall have the power to repeal and amend the By-Laws of this corporation, and shall have the power to adopt new By-Laws; this power may be exercised by the Board of Directors through a majority vote of that Board. By-Laws so repealed, amended, or adopted by the Board of Directors, subject to these Articles and the By-Laws of the

by the shareholders of this corporation at their regular meetings or at any meeting specially called for that purpose. A majority of the shareholders of the corporation may exercise the powers of re-enactment, amendment, or repeal heretofore set out. The By-Laws of this corporation shall regulate the manner of voting for this and other governing actions of the corporation.

### VII.

The amount of the authorized stock of the corporation shall be Twenty Five Thousand Dollars (\$25,000.00), divided into five hundred (500) shares of common stock at a par value of Fifty Dollars (\$50.00) each.
