



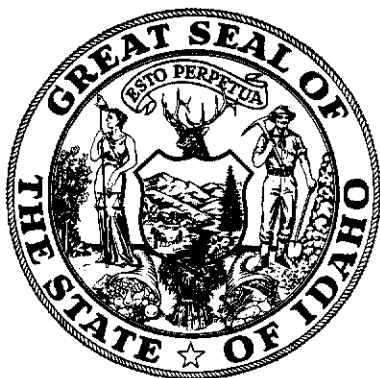
CERTIFICATE OF INCORPORATION

5 The undersigned incorporators, desiring to form a corporation  
6 pursuant to the provisions of the Idaho Business Corporation Act,  
7 adopt the following articles of incorporation:

8 ARTICLE ONE: NAME

9 The name of the corporation is: TOM MAHON LOGGING, INC.

10 ARTICLE TWO: PURPOSES

11 The purposes of the corporation are to engage in the general  
12 lumber business, including timber, milling, and allied interests,  
13 together with the building of railroads, logging roads, and other  
14 things necessary in the full and complete operation thereof; to  
15 engage in a general lumber, timber, kiln drying, milling, construc-  
16 tion materials, and merchandise business; to manufacture, purchase,  
17 or otherwise acquire, sell, or otherwise dispose of logs, lumber,  
18 wood products in a processed or unprocessed state, and by-products  
19 of wood or of said manufacturing operations, and building and con-  
20 struction supplies and merchandise, either at wholesale or retail;  
21 to engage in the business of hauling and transporting logs, timber,  
22 lumber, lumber products, and other freight, goods, wares, and mer-  
23 chandise, by means of trucks, and other forms of transportation,  
24 over public or private highways or roads; and to do such other  
25 things as are incidental, or necessary, to the carrying on of such  
26 business; and to engage in any other or all lawful businesses for  
27 which corporations may be organized under the Idaho Business  
28 Corporation Act.

ARTICLE THREE: DURATION

The period of duration of the corporation is perpetual.

ARTICLE FOUR: REGISTERED OFFICE AND AGENT

The address of the corporation's initial registered office in  
the State of Idaho is HC-62, Box 1235, Hill Road, City of Council,  
County of Adams, 83612; The name of the corporation's initial  
registered agent at such address is JOHN THOMAS MAHON.

ARTICLE FIVE: STOCK

The amount of the total authorized capital stock of this  
corporation is 1,000 shares of common stock without nominal or  
par value, and which shall be all of the same class. Such stock  
may be issued from time to time for such consideration as may be  
fixed from time to time by the board of directors, and shares so

1 issued, the full consideration for which has been paid or delivered,  
2 shall be deemed full paid stock and the holder of such shares shall  
not be liable for any further payment thereon.

3 ARTICLE SIX: RESTRICTION ON TRANSFER OF SHARES

4 Shares in the corporation may be transferred to the corpora-  
5 tion, to other stockholders in the corporation, or to third persons,  
6 but any sale or other transfer to a third person must be approved in  
advance by a unanimous vote of the board of directors.

7 The corporation hereby reserves the right to purchase at the  
8 book value any share or shares of stock which may by any means or  
method become the property of persons, corporations or associations  
ineligible to be stockholders in this corporation.

9 ARTICLE SEVEN: DIRECTORS

10 The business of the corporation shall be managed and conducted  
11 by a board of not less than two (2) and not more than five (5)  
12 directors. The board of directors shall be elected in the manner  
set forth in the bylaws.

13 The number of directors constituting the initial board of  
14 directors is two (2), and the names and addresses of the persons  
15 who are to serve as directors until the first annual meeting of  
the shareholders or until their successors are elected and qualify  
are:
