

## CERTIFICATE OF AMENDMENT

OF

# CERTIFICATE OF INCORPORATION

OF

# AMOCO, INC.

(Pursuant to Section 242 of Title 8, Chapter 1 of the Delaware Code of 1953)

Amoco, Inc. (hereinafter called the "Corporation"), a corporation organized and existing under and by virtue of Title 3, Chapter 1 of the Delaware Code of 1953, does hereby certify as follows:

FIRST: That, upon the unanimous written consent of the holders of all of the outstanding shares of stock entitled to vote of the above corporation, which consent was given pursuant to the provisions of Section 228 of Title 8, Chapter 1 of the Delaware Code of 1953, the following amendment of the Certificate of Incorporation of the corporation has been duly adopted in accordance with the provisions of Section 242 of Title 3, Chapter 1 of the Delaware Code of 1953:

By striking out the Article FIRST thereof in its entirety, and by substituting in lieu thereof a new Article FIRST to read as follows:

"FIRST: The name of the corporation (hereinafter called the corporation) is

### AMOCO OIL COMPANY";

SECOND: That the capital of the corporation will not be reduced under or by reason of said amendment.
