

## Articles of Incorporation.

Know All Men by these Presents, That we the undersigned have this day voluntarily associated ourselves together for the purpose of forming a private corporation under and by virtue of the laws of the State of Idaho, and we do hereby set forth and declare as follows, to wit:

First.

That the name of such Corporation is and shall be, when so formed, The Crook Irrigation Co.

Second.

That the place where the principal business of the Corporation is to be transacted, is the Town of Payette, in the County of Canyon, State of Idaho.

Third.

That the term for which said Corporation shall exist is fifty years.

Fourth.

That the purposes for which said Corporation is formed are the acquiring by purchase or otherwise, water rights, and water locations, the Constructing, extending, enlarging, operating, buying and otherwise acquiring of ditches, reservoirs, dams, aqueducts and other works for the accumulation and conveying of waters from the Payette and Snake Rivers to various points in Canyon County Idaho, and particular to points on the south side of said river and in the Payette Valley, and of rights of way for such ditches and other works above

referred to, and especially to supply and distribute to the stock holders herein, both present and future, water for domestic and agricultural purposes for use on lands lying under said works, or either of them that are now or may be hereafter acquired by such stockholders, or either of them, to sell, lease, rent, furnish, convey, distribute, or in any way supply to others than stockholders in said Corporation any surplus waters that shall be controlled by it over and above that which shall be especially required as aforesaid for the use of such stockholders, which surplus waters shall be so disposed of for agricultural, domestic, manufacturing, Municipal, water power, mechanical, and mining purposes, and for irrigating and reclaiming arid and desert lands, the construction, maintaining, operating, holding and acquiring of water works and water power and real estate, the selling, mortgaging, bonding and leasing, or otherwise disposing of its corporate rights, franchises and any or all of the property, real or personal now belonging, or that shall hereafter belong to or be procured, or controlled by said Corporation and to do any and all such things as are or may be, or become, incidental or otherwise conducive to attaining the objects or any of them herein above referred to.

Fifth.

That the number of the Directors of said Corporation shall be five and the names and residences of those

so appointed as directors for the first year of the life of the Corporation are as follows:

Sixth.

That the amount of the Capital Stock of the said corporation shall be One Hundred Thousand dollars, and the same shall be divided into ten thousand shares of the par value of ten dollars each.

Seventh.

That the amount of said Capital Stock which has been actually subscribed is sixteen thousand, eight hundred dollars by whom the same has been subscribed and the number of shares subscribed, and the number of shares subscribed by such subscribers and the par value thereof are as follows:
