(a) The name of the corporation is Jolly Jump, Inc., and the mailing address is 3968 Summerset, Boise, Idaho 83709.

(b) The names and the addresses of the last officers and directors of the corporation and their respective offices are as follows:

(c) Not less than thirty (30) days prior to the filing of these Articles of Dissolution and following the execution of the written consent of the shareholders to dissolution of the corporation, the corporation has caused notice of its prospective dissolution to be mailed to each of its known actual or known potential creditors in accordance with the requirements of Idaho Code § 30-1-1406.

(d) All debts, obligations, and liabilities of the corporation have been paid and discharged or adequate provision has been made therefor.

(e) All the remaining property and assets of the corporation have been distributed among the shareholders in proportion to their respective rights and interests.

(f) There are no suits pending against the corporation in any court.

(g) At a meeting of the shareholders on May 26, 1999, there were 500 shares issued and outstanding, and 500 shares voted in favor of dissolution.

(h) The dissolution of the corporation has received the unanimous consent of the shareholders, pursuant to Idaho Code § 30-1-1402.

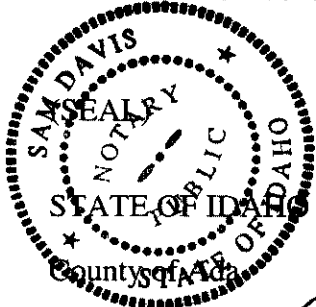

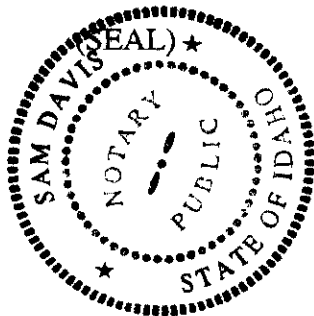
