We, the undersigned incorporators of Western Community Insurance Company, a corporation organized under the laws of the State of Idaho and located in Pocatello, Idaho, hereby certify as follows:

1. The name of the corporation is Western Community Insurance Company.
2. By resolution of the incorporators of Western Community Insurance Company, the following amendment to Article VI of the Articles of Incorporation has been adopted:


ARTICLE VI

Common Shares


The total number of authorized common shares of the corporation is Sixty-Six Thousand (66,000) shares of the par value of Ten Dollars (\$10.00) per share amounting in the aggregate to Six Hundred Sixty Thousand Dollars (\$660,000.00). The common shares of the corporation shall be nonassessable.

3. This amendment was adopted unanimously by the incorporators on July 10, 1980. At the time of the adoption of this amendment there were no shares of the corporation issued ~~or~~ outstanding, and no shares were entitled to vote in this matter; this amendment was adopted by the incorporators as allowed by Idaho Code Section 30-1-59(a).
4. This amendment does not provide for an exchange, re-classification or cancellation of any issued shares.
5. This amendment decreases the amount of stated capital of the corporation from One Million Five Hundred Thousand Dollars (\$1,500,000.00) to Six Hundred Sixty Thousand Dollars (\$660,000.00).
