ARTICLES OF INCORPORATION

OF

IDAHO POTATO PACKERS CORP. OF IDAHO

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, being natural persons of full age and citizens of the United States, in order to form a corporation for the purposes hereinafter stated, under and pursuant to the provisions of the Business Corporation Act of the State of Idaho, and the acts amendatory thereof and supplemental thereto, do hereby certify as follows:

FIRST: The name of the corporation is

IDAHO POTATO PACKERS CORP. OF IDAHO

SECOND: The purposes and objects for which the corporation is formed are:

To buy, produce or otherwise acquire, hold, own, import, export, process, sell, distribute, package, warehouse, store and otherwise deal in and with potatoes and any and all kinds or types of natural food products, and, without restricting the generality of the foregoing, to grow, buy, manufacture, prepare, process, pack, store, refrigerate, sell, distribute or deal in any and all kinds of products, derivatives and by-products thereof and other food and food products, and to manufacture and deal in cans, glassware, packages and containers of any description whatsoever; chemicals, pharmaceuticals and each and every component and raw materials of any and all of the aforesaid articles or commodities.

THIRD: The corporation is to have perpetual existence.

FOURTH: The location and post office address of the registered office of the corporation is c/o Leland Black, P.O. Box 627, City and County of Twin Falls, Idaho.

FIFTH: The total authorized number of shares that the corporation is authorized to issue is thirty (30) shares of capital stock without nominal or par value.

Without action by the stockholders, the shares of stock without par value may be issued by the corporation from time to time for such consideration as may be fixed from time to time by the Board of Directors thereof, and any and all such shares so issued, the full consideration for which has been paid or delivered, shall be deemed full paid stock, and not liable to any further call or assessment thereon, and the holder of such shares shall not be liable for any further payment thereon.

SEVENTH: The directors shall have the power to repeal and amend the by-laws and adopt new by-laws of the corporation, provided, however, that the directors shall not make or alter any by-law fixing their qualification, classification, term of office or compensation.
