## Articles of Incorporation

The undersigned, acting as the incorporator of a corporation, under the Idaho Business Corportation Act, adapts the following articles of incorportation for this corporation:

1. The name of this corporation shall be Future Vision Inc.

2. The period of existence and duration of the life of this corporation shall be perpetual.

3. The address of the initial registered office of this corporation is \$10 N. 21st Boise, ID \$3702. The name of the initial registered agent at such address is ; Todd A. Freer.

4. The nature of the business and the object and purpose of this corporation shall be as follows. The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
