ARTICLES OF MERGER OF KEY BANK OF IDAHO, ON 1941 AN IDAHO CORPORATION, INTO TREASURE VALUE BANK, AN IDAHO CORPORATION SEGRETARY OF STATE

Pursuant to the provisions of Title 26, Chapter 9, of the Idaho Bank Act, and pursuant to the provisions of the Idaho Business Corporation Act, the undersigned corporations adopt the following Articles of Merger for the purpose of merging into one of such corporations:

ARTICLE 1

APPROVAL OF CORPORATE DIRECTORS AND SHAREHOLDERS

The Board of Directors of TREASURE VALLEY BANK, the Board of Directors of KEY BANK OF IDAHO ("Key Bank"), and more than two-thirds of the shareholders of said corporations have approved this Merger.

ARTICLE 2

PLAN OF MERGER

- 2.1 Treasure Valley Bank is a validly organized banking corporation under the laws of the State of Idaho with its principal office at 802 West Bannock, Boise, Idaho. Treasure Valley Bank has, pursuant to its Articles of Incorporation, total authorized capital stock of 100,000 shares of common stock, par value \$100 per share, of which 8,055 shares are outstanding.
- 2.2 Key Bank is a validly organized banking corporation under the laws of the State of Idaho with its principal office at 702 West Idaho Street, Boise, Idaho. Key Bank has, pursuant to its Articles of Incorporation, total authorized capital stock of 1,500,000 shares of non-assessable Common Stock, par value \$20 per share, of which 154,200 shares are outstanding.
- 2.3 Upon the effective date of this Merger, Key Bank shall be merged into Treasure Valley Bank, which shall be the Surviving Bank after the completion of this Merger (the "Surviving Bank"), except that Article VIII (relating to authorized stock) of the Key Bank Restated Articles of Incorporation shall replace Article V of the Treasure Valley Articles of Incorporation. Upon completion of this Merger, the name of the Surviving Bank shall, pursuant to Idaho Code Section 26-907, be "Key Bank of Idaho."
 - 2.4 Upon the effective time of this Merger:

- (a) Each share of Key Bank Common Stock which is outstanding immediately prior thereto shall continue to be outstanding and shall be treated thereafter as a corresponding share of the Surviving Bank; and
- (b) Each share of Treasure Valley Bank Common Stock outstanding immediately prior thereto, by virtue of this Merger and without any action on the part of any holder thereof, shall cease to be outstanding, shall be cancelled and retired without payment of any consideration therefor, and shall cease to exist.
- 2.5 The Board of Directors of Key Bank shall continue after the Merger as directors of the Surviving Bank and shall serve until the next annual meeting of the shareholders. The names and residences of said directors are as follows:

- 2.8 The name and location of the principal and the other offices of the Surviving Bank are the same as set forth in the foregoing Sections 2.6 and 2.7, and the Boise-Capitol Center Office is the principal office of the Surviving Bank.
- 2.9 The Boards of Directors of Treasure Valley Bank and Key Bank reserve the right to withdraw the proposed Merger at any time prior to the filing of the Articles of Merger if the shareholders of Treasure Valley Bancorp, Inc., fail to approve that certain Merger Agreement dated December 7, 1990, by and among Treasure Valley Bancorp, Inc., Equimark Corporation, KeyCorp, and Key Bancshares of Idaho, Inc., as amended by that certain Amendment dated April 25, 1991, to the Merger Agreement by the same parties and joined in by KBI Sub Corp., (as so amended, the "Merger Agreement"), or if the Merger Agreement is for any other reason not consummated, or if the parties hereto determine that consummation of the Merger would not be in the best interests of either of the merging corporations.
- 2.10 The debts, encumbrances, and obligations of Treasure Valley Bank shall become the debts, encumbrances, and obligations of the Surviving Bank.

ARTICLE 3

SHAREHOLDER APPROVAL

Pursuant to Idaho Code Section 26-904, the Merger identified herein has been approved by no less than two-thirds of the shareholders of each of the corporations that is a party to this Merger.

Pursuant to Idaho Code Section 26-904, the Merger identified herein has been approved by no less than two-thirds of the shareholders of each of the corporations that is a party to this Merger. Pursuant to Idaho Code Section 26-904(2), each of the corporations that is a party to this Merger has received waivers from its respective holders of two-thirds of the outstanding shares of its stock waiving notice by publication of the meetings of the shareholders of said corporations where this Merger was considered.
