ARTICLES OF INCORPORATION
OF
TOPDOG WRESTLING CLUB, INC.

ARTICLE I

The name of this corporation is TOPDOG WRESTLING CLUB, INC.

ARTICLE II

The corporation is a non-profit corporation.

ARTICLE III

The corporation shall have perpetual existence.

ARTICLE IV

This corporation is organized exclusively for religious, charitable, scientific, literary or educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code. Upon winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to a nonprofit fund, foundation or corporation which has established its tax exempt status under section 501(c)(3) of the Internal Revenue Code.

The corporation is totally volunteer and founded to support amateur wrestling in Bonner County, Idaho. The

organization has monthly meetings, fund raisers, and schedules wrestling matches and practices. The age of wrestlers is generally 6 years to 18 years old.

Article V

The corporation will be composed of members who pay \$1.00 annual dues. This will entitle anyone who is a member to vote for Board of Directors.

Article VI
