KNOW ALL MEN BY THESE PRESENTS, That the undersigned, being at least two-thirds of the Trustees of The College of Idaho, DO HEREBY CERTIFY, that the Fourth Paragraph of the Articles of Incorporation of said The College of Idaho is hereby amended to read as follows:

Fourth. That the number of Trustees shall be eighteen, besides the President of the institution who shall be ex-officio a member of the Board of Trustees. The term of office of such Trustees and the manner of their election shall be provided by the By-Laws.
