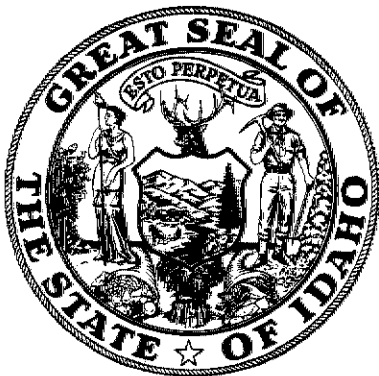
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION
OF
C AND H DATA, INC.

The undersigned, acting as incorporators of the corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is C and H DATA, INC.

SECOND: The period of its duration is perpetual.

THIRD: The corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act including but not by way of limitation the purpose of selling computer equipment and software.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 10,000 shares with no par value.

FIFTH: The address of the initial registered office of the corporation is 999 Federal Way, Boise, Idaho, 83705, and the name of its initial registered agent at such address is James Hawkins & Peter Matthew Christopherson.

SIXTH: The number of directors constituting the initial Board of Directors of the corporation is two (2) and the name and address of the persons who are to serve as Director until the first annual meeting of share

holders or until a successor is elected and shall qualify is:

SEVENTH: The name and address of each incorporator is as specified in Paragraph Sixth above.

EIGHTH: Amendment of the By-Laws of the corporation by the Board of Directors shall require majority approval of those directors present either in person or by proxy at a meeting of the Board of Directors duly called at which a quorum is present.

NINTH: The Board of Directors may create such committee or committees as it deems to be necessary or advisable with only such power and authority as is specifically defined in the resolution establishing such committee.

TENTH: The Articles of Incorporation shall not be removed, modified or amended except upon approval of a majority of all of the shareholders at a regular or special meeting of the shareholders called for such meeting.


