ARTICLES OF AMENDMENT
OF
BOISE RECYCLING CENTER, INC.

Pursuant to Section 30-147 of the Idaho Code, the undersigned corporation adopts the following amendment to its Articles of Incorporation:

ARTICLE I

The following resolution of amendment of the articles of incorporation was adopted by a vote of a majority of the members of the corporation on June 20, 1974, in the manner prescribed by the laws of the State of Idaho, and the articles of incorporation of the corporation:

WHEREAS a majority of the members of Boise Recycling Center, Inc. desire to amend the Articles of Incorporation to provide for changing the name of the corporation to Recycling Committee, Inc;

NOW, therefore, be it resolved that the Articles of Incorporation be, and they hereby are, amended by striking therefrom Article I and adding thereto the following new Article I, which shall read as follows:
