The undersigned, acting as the incorporator of a nonprofit corporation (the Corporation) organized under and pursuant to the Idaho Nonprofit Corporation Act, Chapter 3, Title 30, Idaho Code (the Act), adopts the following Articles of Incorporation.

ARTICLE 1: The name of the Corporation is Central Idaho Mountain Bike Association, Inc.

ARTICLE 2: The Corporation is a non-profit corporation.

ARTICLE 3: The purposes for which the Corporation is organized are to:

- i. advocate the sport of mountain biking,
- ii. educate members and the mountain biking community about safe and responsible trail usage,
- iii. advocate preservation of open spaces and trail access,
- iv. participate in trail/trail system development and maintenance,
- v. encourage dialog between trail users and public/private landowners,
- vi. charitable, religious, educational, or scientific within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended from time to time (the Code), including for such purposes, the making of distributions to organizations that qualify as tax exempt under such section, and
- vii. exercise all powers granted by law necessary and proper to carry out the forgoing purposes, including, but not limited to, the power to accept donations of money, property, whether real or personal, or any other things of value. Nothing herein contained shall be deemed to authorize or permit the corporation to carry on any business for profit, to exercise any power, or to do any act that a corporation formed under the Act, or any amendment thereto or substitute therefor, may not at that time lawfully carry on or do.

ARTICLE 4: The street address of the registered office is 1037 Potts Drive, McCall, ID 83638. The registered agent at such address is: William Oldham.

ARTICLE 8: The Corporation will not have voting members.

ARTICLE 9: Upon dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the corporation, distribute all the assets of the corporation consistent with the purpose of the corporation to such organization or organizations as shall at the time qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended from time to time, in such manner as the Board of Directors shall determine. Any such assets not so distributed shall be distributed by the district court of the county in which the principal office of the corporation is then located; exclusively for the purposes or to such organizations as such court shall determine to be consistent with the purpose of the corporation.
