Pursuant to Sections 30-1-58 and 30-1-59 of the Idaho Code, BIRCHLIGHT INDUSTRIES, INC., an Idaho corporation, adopts the following articles of amendment to its Articles of Incorporation filed November 12, 1987:

ARTICLE I. The name of the corporation is BIRCHLITE INDUSTRIES, INC.

ARTICLE II. The amendment to the Articles of Incorporation is the change of the corporation name from BIRCHLITE INDUSTRIES, INC., to IDAHO WOODWORKS, INC..

ARTICLE III. The amendment herein was adopted by unanimous vote of all the shareholders of the corporation at a meeting held in Sandpoint, Idaho, at the Quality Inn, on July 18, 1991.
