Pursuant to the provisions of Section 30-327 of the Idaho Non-Profit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is The American Heart Association of Idaho, Inc.

SECOND: The following amendment to the Articles of Incorporation were adopted by the members of the Corporation on the 12th day of May, 1990, in the manner prescribed by the Idaho Non-Profit Corporation Act:

## ARTICLE VII

The management and control of this corporation shall be vested in the Board of Directors of said corporation, which shall number not less than twenty five nor more than fifty five. The existing Board of Directors shall elect their successor directors.

The amended Article replaces the previously existing Article VII.

THIRD: A quorum of the members of the corporation were present at the above-referred to meeting and a unanimous vote of those present at such meeting in person or by proxy were cast in


