

**ARTICLES OF INCORPORATION

The undersigned person, being of lawful age, for the purpose of forming a corporation under the laws of the State of Idaho, adopts the following Articles of Incorporation:

Article One

The name of the corporation is N-Viro Solutions Corporation.

Article Two

The corporation is formed for the following purposes:

1. To create, own, hold, conduct and develop a company dealing in all types of environmental endeavors, including, but not limited to environmental consulting, environmental protections, and environmental cleanup.
2. To own and hold real estate, construct and erect buildings and structures of all types, and to buy, sell, lease, manage, operate, maintain, repair, and/or rebuild same.
3. To acquire, hold, own, buy, sell, transfer and otherwise dispose of all types of equities, all types of assignments, patent rights, trademarks, copyrights, intellectual properties, licenses, franchises, permits and other evidences of right.
4. To enter into, make, perform, and carry out contracts of every sort and kind, for any lawful purpose, with any person, firm, association or corporation, state, territory, or country.
5. To organize, maintain and service all types of company divisions, distributorships, franchises and other companies both within and without the United States.
6. To do any and everything necessary or convenient for the accomplishment of any of the purposes or the attainment of any of the objects or the furtherance of any of the powers hereinabove enumerated, either for itself or as agent for any person, firm, or corporation, or other entity.
7. To engage in any other lawful business or operation deemed advantageous or desirable, and to do any and everything incidental to, growing out of, or germane to any of the foregoing purposes or objects conferred by the laws of the State of Idaho upon corporations formed under the Act relating thereto.

Article Three

The aggregate number, class and par value, of the shares that the corporation shall have authority to issue shall be Nine Hundred and Five Million (905,000,000) shares of common stock at no par value.

There are no preferences, qualifications, limitations, restrictions, special or relative rights, including convertible rights.

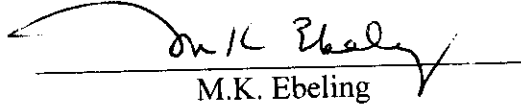
Article Four

The number of directors to constitute the first board of directors is three (3). Thereafter, the number of the directors shall be fixed by, or in a manner provided in the by-laws.

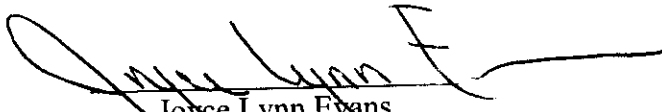
Article Seven
