TROOP G, 2/116th ACR NONCOMMISSIONED OFFICERS CLUB INC. SECRETARY OF STATE

1. The name of the Corporation is Troop G, 2/116th ACR Noncommissioned Officers Club, Inc.
2. The corporation is a non-profit corporation.
3. The period of its duration is perpetual.
4. The purposes for which the corporation is formed are to provide such facilities, equipment or service within its resources, and to conduct such recreational and Social activities for its members as are deemed necessary and proper by its Board of Directors.
5. The Location of the initial registered office is 2000 E. Main or P.O. Box 1166, Burley, Idaho 83318. The name of the initial registered agent at that address is R. Kirk Beck, SSG, Unit Administrator.
6. Members of the corporation shall be admitted in accordance with the bylaws.
7. The number of directors shall be not less than three(3) and not more than nine(9). The number of directors shall be set by the bylaws. Directors shall be elected annually by straight voting.
