ARTICLES OF INCORPORATION  
OF  
CHALLIS FRIENDS OF THE LIBRARY, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, all of whom are bona-fide residents of the State of Idaho and citizens of the United States, have this day voluntarily associated ourselves together for the purpose of forming a non-profit corporation under the laws of the State of Idaho.

We do hereby certify, in writing, the following:

I.

This Corporation is a non-profit corporation formed pursuant to the "Idaho Nonprofit Corporation Act".

II.

The name of the said corporation shall be known as: CHALLIS FRIENDS OF THE LIBRARY, INC. The principal place of business shall be in the County of Custer, State of Idaho, and the post office address shall be c/o Challis Public Library, P. O. Box 186, Challis, Idaho 83226. The name of the registered agent and the agent's address are: President, CHRISANNE BROWN, P. O. Box 381, Challis, Idaho 83226.

III.

The corporation shall be nonstock, and no dividends or pecuniary benefits or profits shall be declared to the members thereof.

IV.

The period of existence and the duration of the life of this corporation shall be perpetual.

V.

The qualifications upon which members shall be accepted and expelled or reinstated shall be provided for in the By-Laws of said corporation.

VI.

The relative rights of members are equal and are included in the By-Laws.

VII.

All other provisions relative to membership and election or appointment of officers or directors and all matters relative to the holding of meetings shall be provided for in the By-Laws.

VIII.

The officers of this corporation shall consist of a president, vice-president, secretary and treasurer, and three elected directors, unless otherwise provided in the By-Laws or as provided in amended By-Laws. Any member may hold more than one elective or appointive office or position.
