That I, the undersigned, being of full age and a citizen of the United States, have this day voluntarily associated for the purpose of forming a corporation under the provisions of Idaho Code 30-101 et. seq.:

ARTICLE I

NAME

The name of said corporation shall be Treasure Tours, Inc.

ARTICLE II

PURPOSES AND POWERS

The purpose for which this corporation is formed is to engage in and conduct all lawful business.

ARTICLE III

DURATION

Subject to dissolution in the manner provided by law, the corporation shall be perpetual.

ARTICLE IV

REGISTERED OFFICE

ARTICLE V

CORPORATE STOCK

A. The aggregate number of shares which the corporation shall have authority to issue is
Ten Thousand (10,000), all of which shall have no par value. All such shares shall be common
voting shares.

B. The relative rights, privileges, and limitations of all shares shall be in all respects
identical, share for share.

MANAGEMENT

A. The business of the corporation shall be managed by a board of not less than
one (1) and not more than seven (7). Directors need not be shareholders. A director shall hold
office for the term for which he was named or elected and until his successor is elected and
qualified.

B. The Incorporator listed in Article VI above shall serve as director until the first
meeting of shareholders or until successor director or directors are elected and qualify.

ARTICLE VIII

BY-LAWS

The power to adopt, repeal and amend the By-Laws of the corporation shall be in the stockholder(s) and the By-Laws may be amended, adopted, or repealed by a majority vote of the stock issued and entitled to vote.
