ARTICLE 1. ASSETS

All assets of the Intermountain Regional Learning Center (IRLC) will be donated to the McCall Technology Institute (MTI), which qualifies as an exempt organization under section 501 (c) (3) of the Internal Revenue Code of 1986 . This organization will carry on a similar purpose as the IRLC. It is an educational institution working to enhance availability of education and training to the citizens of McCall and the surrounding region of the central Idaho mountains.

ARTICLE 2. DONATED ITEMS

The sum total of all assets consists of office equipment and supplies, worth approximately \$2000, all owned free and clear by IRLC. Also donated will be remaining cash in checking account in the amount of approximately \$370 .

ARTICLE 3. REAL ESTATE

The IRLC owns no real estate.
