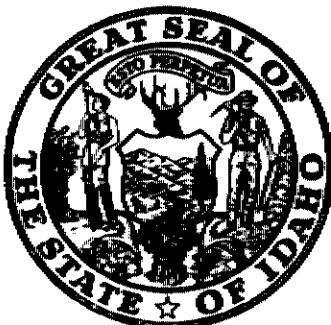

Pursuant to the provisions of the Idaho Business Corporation Act, Title 30 and Pursuant to Idaho Code Section 30-1-59 through Idaho Code 30-1-63, the following Articles of Amendment to Articles of Incorporation are submitted for filing.

ARTICLE I

The name of this corporation is Wm. Thomas Baker, P.A., (the "Corporation").

ARTICLE II

Amendments to the Corporation's Articles of Incorporation are adopted as follows:

- a. The FIRST Article shall be deleted and replaced with:

"FIRST the name of the Corporation is BAKER & ANDERSON, CPAs, P.A."

- b. Article TENTH is added to read as follows:

"TENTH: Pursuant to Idaho Code Section 30-1310, as amended, the transfer of shares of stock in the Corporation shall be restricted according to the terms set forth in the Bylaws of the Corporation."
